Processing purposes

Vansichen Linear Technology collects and processes the personal data of customers for customers and order management (including customer administration, follow-up of orders/deliveries, invoicing, follow-up of solvency and sending of marketing and personalised advertising).

To measure B2B use of our website, we use the <u>Leadinfo</u> service based in Rotterdam. This service shows us company names and addresses based on the IP addresses of our visitors. The IP address is not stored after use.

Legal foundation(s) of the processing

Personal data are processed based on article 6.1. [(a) authorisation,] [(b) (required for the implementation of a contract),] [(c) (required for the meeting of a legal obligation)], [(f) (necessary for the representation of our justified interest to enterprise)] of the General Data Protection Regulation.

[To the extent that the processing of the personal data takes place based on article 6.1. a) (authorisation), the customer always has the right to withdraw the granted authorisation.]

Transmitting to third parties
